## Terms & Conditions for Sale of Kitten

Buyer agrees to the following terms of the contract when placing a deposit and purchasing a kitten sold from *Dynasty Maine Coons*.

***The Total Amount Due of the stated kittens: \$***

1. Once Kitten leaves the cattery, the new adoptive client is responsible for **all** safety and medical expenses. Buyer is responsible for all veterinary and professional expenses on behalf of the kitten. The Seller **is not responsible**, at any time, for any veterinary bills or any other financial expenses, or health related issues related to the kitten once the kitten leaves for their new home. Buyer agrees to continue necessary vaccinations such as treating for worms, parasites, heartworm, rabies, FIV, and FELV, and fleas. Buyer agrees to bring kitten to licensed veterinarian within **ONE WEEK** for a health check and to ensure the kitten is free of illness or any life-threatening congenital defects. This contract will be null/ void if failure to do so.
2. This Kitten, **to the best of the breeder's knowledge, is healthy at time of sale.** All kittens have been examined and vaccinated. All Dynasty Maine Coon Kittens, that is kittens sold by our cattery, have been **health certified** before leaving for their new home. Dynasty Maine Coons are is not liable for genetic issues that may affect your cat or kitten such as Pkdef, PKD or HCM. Although Dynasty Maine Coon Cattery screens some of our cats for diseases known to affect Maine Coons, the Buyer agrees that there is no guarantee that this kitten will not develop a disease. Dynasty Maine Coons is not fiscally responsible for any health conditions that may occur after sale of kitten. Seller guarantees that upon renouncing ownership to the Buyer, the kitten has been vet checked and is guaranteed to be in sound health prior to leaving for their new home. Dynasty Maine Coons makes **no guarantee on the kitten's current or future color, size, traits, or temperament.** Cat or Kitten purchased is **health guaranteed up to one year.** This means, if said cat or kitten **dies** by the time they are one year old **from a genetic defect** cat or kitten will be replaced with a kitten from future litter. Dynasty Maine Coons is under no obligation to return money of the sale to the buyer.
3. Seller agrees that the Buyer is purchasing a purebred Maine Coon kitten. This cat or kitten is **sold for PET ONLY. TICA registration papers are given to the Buyer** once the Seller transfers ownership to the buyer. Buyer understands there is a non-return policy once ownership rights are transferred.



4. Buyer agrees that seller has **no control over the kitten's environment after sale kitten leaves our cattery**. Seller is not responsible for health conditions kitten may develop such as bacterial infections, intestinal parasites, giardia , or any other common diseases or medical conditions. Buyer is responsible for all veterinary and professional expenses incurred on behalf of the kitten.
  
5. No Cat or Kitten from Dynasty Maine Coons will be given to an animal shelter, sold, given to a pet store, abandoned, or otherwise transferred to any party other than one approved by breeder. Breeder must be contacted to re-home kitten at expense.
